

Thank you for your interest in becoming an Official Tournament Store (OTS) for KONAMI. To start the process, we have a brief questionnaire for you to fill out. It starts on the next page and on the last page is a Submit button that will open your email client and generate an email with the filled-out questionnaire attached.

The form is designed to be used with Acrobat Reader only. While both the Chrome Browser and Apple Computers have preview programs that open PDF forms, they do not allow the user to save the information they enter and can also interfere with the Submit button. A link to get the free Acrobat Reader is below.

If you are having issues with the submit functionality of the form, simply save it when completed and send as an email attachment. Please check it after you save it to make sure the information you entered was saved.

In addition to the questionnaire, we also need some additional information sent to us as attachments. We must save the files so please do not send a link. We need:

A copy of your business license and a government issues document (such as a utility bill) that shows your store's name and physical location.

At least one photo of the interior of your store showing tournament space seating (minimum of 16 players seated across from each other).

At least one photo of the interior of your store showing a Yu-Gi-Oh! TRADING CARD GAME specific retail area.

At least one photo of the exterior of your store including a wide shot of the building.

At least one photo of your permanently affixed store sign.

The inbox has a limit of 5 MB per email so please send the pictures in multiple emails, if needed.
